# Overview and Highlights

▲ Social Economy Project Update

#### Linking, Learning, Leveraging: Social Enterprises, Knowledgeable Economies, and Sustainable Communities

Much time has been spent putting all the administrative processes in order to get the regional node up and running following a highly successful symposium to kick-start the project in Saskatoon in late January. Since then, we have obtained ethics approval, signed sub-transfer agreements with the partner universities, and transferred funds. In northern Ontario, Gayle Broad organized a symposium with thirty participants in late April to begin building a research network of academics and community partners. Research projects will be initiated during the summer. In Saskatchewan and Manitoba, research internships have been advertised and filled. The Winnipeg Inner-City Research Alliance has filled two, twelve-month, masters-level internships, while the Community-University Institute for Social Research in Saskatoon has filled three, four-month, doctoral-level internships, and with matching funds, has also filled a fifteen-month internship partnered with the Co-operatives Secretariat. The management board for the node met in late May to begin developing an integrated research plan for the region.

### ▲ Social Cohesion Project Update

Research is in its final stages for all clusters, with most participants hoping to wind things up over the summer. Researchers have been making use of their findings in conference presentations and workshops, and many of the results have found their way into the second book to come out of the project — "Imagination, Identity, and Cohesion: Co-operative Community Responses to Globalization in Canada" — begun at the fall writers' workshop. Drafts are in for all chapters and we are extremely pleased to note that they are currently out for review with the University of Québec Press, which is considering a French version of the book.

Angela Wagner is going to Ghana in a position as a reproductive health officer; she will be collecting baseline data on rural male and female artisans. Kim Brown is going to Kenya, where she will work with the Swedish Co-operative Centre on a project titled "Community Empowerment and Enterprise Development through Co-operatives." They will both be serving six-month terms.

Centre Scholars Annual Update

Isobel Findlay participated in the Waskesiu writing workship last fall and was part of the team that taught the centre's Interdisciplinary Studies 898 class that semester, Co-operatives and Sustainable Development: Comparisons between Mongolia and Canada. She was a guest lecturer on Aboriginal cooperatives in Commerce 345, Business and Public Policy, in March. She continued her duties as supervisor of three PhDs in the Co-op Concentration and is a member of one PhD and two MA committees on co-op topics. With Kitty O. Locker, she is the author of the new textbook titled *Business and Administrative Communication: Canadian Edition* (Toronto: McGraw-Hill Ryerson, 2006), which features a number of co-op examples. She gave a presentation titled "Putting Co-operative Principles into Practice: Lessons Learned from Canada's North" to the ICA Research Conference in Cork, Ireland, in August 05; and presented with Lou at Arctic Co-operatives Limited's AGM in Winnipeg in May 2006. She remains heavily involved in the centre's Social Cohesion project and is also a co-applicant in the new Social Economy project as well as a collaborator on the national hub for the same work. Finally, Isobel is a regular participant in centre social events.

Morris Altman is involved with cluster one of the Social Cohesion project.

Ian MacPherson and Ellen Goddard participated in this year's CASC conference, with Ellen being acclaimed president for the coming year.

**Dan Ish** is heavily involved with the China Project and has a centre booklet coming out; he also participates regularly in centre social events.

Sheryl Mills teaches a class in co-operative learning through the College of Education. She is also working with Dr. Rani Kanthan in the Department of Pathology on introducing a variety of active learning strategies, including cooperative learning, to dental and medical students taking pathology. They presented their materials at a national conference and are working on an article for submission to a medical journal.

Louise Clarke participated in the development of the Social Economy proposal and is a member of the cluster studying social enterprise development. She is chair of Monica's PhD committee and a member of Rochelle's. She also participates regularly in centre social events.

Marj Benson is working on another of her mammoth casebooks, this time the result of interviews with senior legal practitioners in Regina, Saskatoon, and Calgary on negotiating ethics, most of which are based on the concept of co-operation. The project is funded by the Law Foundation of Saskatchewan and the College of Law.

Credit Union Central of Saskatchewan (Karl Baumgardner reporting)

The last report, 22 March, contained the 2005 financial results, a year after the restructuring of SaskCentral and Co-op Trust that led to the formation of Concentra Financial. SaskCentral continues as a trade association for Saskatchewan credit unions and also provides strategic investment management. As of 31 March 2006, SaskCentral's assets were \$1.3 million, equity was

\$184.6 million, and earnings were \$1.65 million. Investee earnings/equity
pick-up (in millions) were as follows: CUETS: \$2.076; CUPS: \$0.123; CELERO:
(\$0.092); CUCC: \$0.092; CUMIS: \$0.122; Co-operators: \$0.138; Concentra:
\$2.34.

In terms of initiatives, the Entrepreneurial Foundation and Fund are functioning and the Aboriginal Business Strategy is serving credit unions.

Board reorganization for 2006–07 includes Gordon Lightfoot (Southwest Credit Union) as president, Dennis Anderson (Conexus Credit Union) as first vice-president, and Vern Buck (Spectra Credit Union) as second vicepresident.

#### Credit Union Central of Canada (Karl Baumgardner reporting)

Credit Union Central of Canada and Concentra Financial held their AGMs in Vancouver in conjunction with the annual national conference of Canadian credit unions this spring. President Mike Tarr (BC) reported the highlights as follows:

- ▲ 2005 was a good year
- ▲ the Small-to-Medium-Size-Enterprise initiative is moving forward
- ▲ the chip card technology is a high priority, with a launch in Kitchener-Waterloo in 2007 and anticipated compliance for all financial institutions by 2015
- ▲ the federal government indictated that bank mergers are not imminent
- ▲ the twelve largest credit unions are leading two other initiatives 1) the creation of a single credit union central for all provinces; and 2) an examination of the merits of legislation to allow co-operative banks

Interim CEO David Phillips reported a follows:

- ▲ system assets grew by 10.8% to \$87 billion; deposit growth was 10.7%; and loans 12.7%
- ▲ membership increased to 4.9 million, up from 4.7 million
- ▲ the number of credit unions stands at 526, a reduction of 40

Achievements for 2005 include the restoring of Acculink service, active lobbying of the federal government, and the growing success of CUSOURCE<sup>\*</sup> as a national learning centre. A Members' Forum enabled all participants to contribute their ideas about issues facing Canadian credit unions. The results will be shared and provide guidance for CUC Canada's board.

- ▲ president and CEO Michael Porter resigns
- ▲ Kenneth Lalonde announced as new president and CEO

- ▲ attended and presented to a symposium organized by Gayle Broad of the northern Ontario sub-node, 20–21 April 06 at Algoma University College in Sault Ste. Marie. The thirty people in attendance represented social economy organizations across northern Ontario.
- ▲ held the first in-person meeting of the management board for our node in Toronto in late May

#### Summary Reflecting the Centre's Strategic Plans

#### Lorraine Salt

#### Summary Reflecting the Centre's Strategic Plans

Through collection development and the provision of resources, Lorraine has contributed to strengthening graduate-level education and research around co-operatives. The centre's library is considered the best co-operative research library in Anglophone Canada. As well, Lorraine favours a service-oriented approach to dealings with students at all levels, providing assistance in research and materials searching that is relevant to the needs of the students. This applies to the centre's own graduate students, to those in other programs across campus, and also to students who make requests from other institutions.

As a part of the application process and now project administrator for two, multi-year, multi-partner SSHRC grants, Lorraine contributes significantly to strengthening the centre's Canadian and international academic profile. With several of our Social Cohesion research partners, she also helped organize the Ottawa policy conference in March, which was targeted at government policy makers. In addition, it is clear from the inquiries we receive that the centre's main website and the two project sites reach an international audience.

Through a new outreach initiative — addressing students in co-operative courses and speaking at future meetings of the Saskatoon Co-op Network, as well as seeking new ways of inviting constituents into our library — Lorraine is contributing to the cultivation of connections with both the university community and the co-op sector.

As a member of the Social Economy/Co-op Data Centre team, an initiative to collect and database raw research materials, Lorraine is involved in generating new ways to disseminate data on research about co-operatives and the social economy. Our centre website, as well as the two project-related sites, are also useful for sharing research. Lorraine created an on-line discussion forum for the Social Economy project to facilitate sharing of research among cluster members, and parts of the site are accessible to the general public.

In speaking to Brett's undergraduate course, and making plans for future similar outreach, Lorraine is helping to develop undergraduate university education about co-operatives.

**Dwayne Pattison** has finished the first year of his MA and is taking a methodologies class in intersession, which will be the last class of required coursework. Beginning in September he will be focusing on collecting data and writing his thesis, which will examine the regionalization of co-operatives in northern Saskatchewan. During the summer he will be assisting Michael in wrapping up his research for the Social Cohesion project. With Angie, he attended the Co-op Youth Conference in Manchester, a highlight of which was visiting the original store of the Rochdale Pioneers in Toad Lane. From there he went to the CASC conference in Toronto and participated in the presentation of two case studies: "The Darkhan Wool Co-operative," with Jason, and "The Ansondor Savings and Credit Co-operative: Micro-Credit in Rural Mongolia," with Monica. Later this summer, with Angie, he will be staffing the Saskatchewan Co-operative Association Youth Camp, which he attended as a camper, little suspecting he would one day return as a supervisor.

**Rochelle Smith** continues to work on her PhD dissertation, preparing case studies of three community clinics in Saskatchewan, one each in Saskatoon, Regina, and Prince Albert. She is in the process of conducting and analysing key informant interviews with clinic board and administration representatives, corresponding representatives of their respective health regions, current and former MLAs, Saskatchewan Health officials, and several health-care experts. The title of her dissertation is "The Relationship of Saskatchewan's Co-operative Community Clinics with the Government of Saskatchewan: Toward a New Understanding."

Mitch Diamantopoulos has finished the first year of course work for his PhD program and is working for the summer on a CUISR internship carrying out reconaissance research in three social economy milieux — inner-city Saskatoon, LaRonge, and a rural community to be determined. And to the four awards he received this past year, he has now added another two — one of the Lemaire Co-operative Studies Awards and an Interdisciplinary Studies Scholarship.

**Juanita Bacsu**, a former summer student, has rejoined us to work on research for the Social Economy. She has recently finished the course requirements for her MA program in Political Studies. Her thesis is examining citizen attitudes toward globalization, which is based on the Social Cohesion project.

Dan Macfarlane, a former MA student of Brett's, has joined us this summer to produce an oral/video history through interviews with individuals who have made significant contributions to the co-operative community in Saskatchewan. The interviewees are drawn from a diverse range of backgrounds, including some from major organizations such as the Wheat Pool, FCL, and Credit Union Central of Saskatchewan, and others from locally based, independent co-operatives in both urban and rural locations. The collection of interviews will be housed in the centre's library and will comprise a valuable resource for future researchers. Selected highlights, complemented by written biographical and organizational history, will be edited into documentary programs for use in university courses.
