Overview and Highlights

Sponsors Honoured

We are pleased to acknowledge yet more important honours for Centre sponsors. Saskatchewan's Credit Union Central has been named Canada's top workplace for women, and one of the top one hundred best places to work in Canada for 2011. SaskCentral received the honour from the Great Place to Work Institute, which published its list in the *Globe and Mail* on 12 April, the day before SaskCentral's annual general meeting.

And the Co-operators has been ranked #1 among the Best 50 Corporate Citizens in Canada by Corporate Knight, an organization dedicated to the promotion of responsible business practices in Canada and the advancement of social and environmental sustainability worldwide.

The Building Renovations

The Centre has been affected to varying degrees during the extensive renovations to the Diefenbaker Centre where we are housed, though for the most part, we have carried on as usual. A significant disruption occurred in May, when we all had to vacate our offices for a couple of weeks while the flooring was being replaced. Temporary accommodation elsewhere in the building kept most of us on site and no work days were lost, although the move both in and out took considerable time, effort, and planning. The next phase will involve emptying the library of its more than five thousand items, plus all the built-in shelving, in order to replace the floors in that area.

▲ A New Communications Strategy

We have been engaged for several months in discussions with University Communications on a new communications strategy for the Centre. The plan aims initially to obtain a stronger provincial profile for the Centre using the Building Community exhibit as an example of best practice in community engagement and community-based research. It is intended as a first phase in a comprehensive communication plan to promote the centre's research nationally and internationally.

▲ Centre Review

The report from the external examiners contains many positive observations about the Centre and suggestions pertaining to further development of our teaching, research, and outreach programs. Centre Fellows Michael, Lou, Brett, and Murray have discussed the content and Michael and Lou have also met with VP Research Karen Chad, whose office is ultimately responsible for the reviews of all centres on campus. Michael is in the process of drafting a response to the report, which will go to the VP Research office.

▲ International Year of Co-operatives

Planning is underway for activities at the Centre celebrating the International Year of Co-operatives in 2012. Ideas include inviting senior co-op leaders to speak on campus, erecting appropriate signage to acknowledge Centre sponsors (once the building renovations are complete), and hosting a conference focusing on the roles of co-operatives in building western Canada and USA, and public policy to support this contribution, in the fall of 2012.

Building Community Exhibit

The hundred panels are currently safely stored in custom-built travelling crates awaiting their next engagement. A number of organizations and communities have expressed an interest in hosting the exhibit, and the somewhat complex logistics of doing so are being discussed and worked out. We are also awaiting the results of a Research and Knowledge Development (RKD) funding application which, if successful, would allow us to move onto the second stage of this large project — reconfiguring the exhibit into three travelling components for circulation in the areas under study — Northern Ontario, Manitoba, and Saskatchewan. The objective of RKD is to encourage research and dissemination projects that will advance the understanding of co-operatives' contributions to addressing challenges in a variety of areas. It is a component of the Co-operative Development Initiative funding administered by the federal government's Rural and Co-operatives Secretariat.

▲ Social Economy Project Update

All the regional workshops planned for this five-year venture have taken place and researchers and students are busy finishing up projects and writing final reports as this major project begins to wind down. The Canadian Association for Studies in Co-operation (CASC) and the Association for Nonprofit and Social Economy Research (ANSER) conferences in Fredericton in early June (held on the University of New Brunswick campus in conjunction with the Congress of the Social Sciences and Humanities) provided an opportunity for the presentation of research results from sixteen projects. Nora has completed the editorial work and print supervision on several more reports, bringing the total to about a third of the final count. Heather is making preparations to collect the material for the final report on the overall project to the funder, the Social Sciences and Humanities Research Council of Canada (SSHRC), which is due February 2012. There has been some discussion about a wrap-up conference involving all six Social Economy research nodes across the country, but no decision has been taken to date.

▲ Impact of Co-operatives Research Update

Research is on-going on Measuring the Social, Environmental, and Economic Impact of Co-operatives in Canada, spear-headed by the Canadian Co-operative

Association (CCA). The Centre is working on two projects: Measuring the Impact of Credit Unions on Wealth Building in Communities and The Impact of Cooperative Housing on Household Income, Skills, and Social Capital. This is a five-year, \$1 million SSHRC-funded project involving CCA, the Centre, Saint Mary's University, the University of Victoria, and Mount Saint Vincent University, plus more than a dozen co-operative associations, co-ops, and credit unions. Co-leads are John Anderson, CCA's director of government affairs and public policy, and Sonja Novkovic, professor of economics at Saint Mary's University.

▲ The Canadian Association for Studies in Co-operation (CASC) Conference

The CASC conference is the main venue for the dissemination of co-op research in Canada, in fact the only annual conference devoted exclusively to co-operative topics. This year it was held in Fredericton, 1–3 June, in conjunction with the Congress of the Humanities and Social Sciences, Canada's largest multidisciplinary academic gathering. CASC makes great efforts to include young scholars, many of whom make their first public presentations at the CASC meetings. The Centre serves as the CASC secretariat, which means we are heavily involved with the association on an ongoing basis.

This year the conference, titled Co-operation in a Changing Economy: The Role of Collective Innovation and Social Entrepreneurship, attracted researchers from across Canada as well as the US, the UK, France, and Italy. The conference featured twenty-two concurrent sessions representing fifty-nine papers, in addition

to ten joint sessions with the Association for Nonprofit and Social Economy Research (ANSER), as well as a session with ERA-Can (the European Research Area and Canada), an organization that encourages and facilitates Canadian researchers and organizations to collaborate with European researchers to increase the quality of their networks and the impact of their resources and projects. The conference also included a youth-student co-op workshop and planning for the Internation Year of Co-operatives in 2012. Organizers were fortunate to secure Professor Carlo Borzaga from the University of Trento in Italy as the keynote speaker, who gave a presentation titled Social Innovation and New Enterprise Models and Opportunities.

The Websites and LLL Project

Most of Heather's time has been dedicated to website maintenance, updating, and continued development, both on the Centre website and the LLL site. She added a separate blog to our website as a repository for relevant local, national, and international information about co-ops and credit unions.

Making preparations for the final report for the Social Economy project, due 28 February 2012. Gathering and preparing the data will require a great deal of work from a number of Centre personnel.

The Library

The library is in a state of upheaval while the flooring is being replaced. The removal and replacement of the books as well as the shelving is a significant undertaking, and while the heavy work will not be done by Centre staff, Heather and Karen have been planning and overseeing the process to ensure that the move goes as smoothly as possible. We did a complete shelf-reading of the collection to make sure all the books were in order last summer and do not wish to do such an intensive job again so soon. While the library is dismantled, Facilities Management will also be making minor improvements to air circulation and heating/cooling in the library.

▲ Google Analytics

Google Analytics allows us to track visits to our websites, which will be helpful in the further development of these sites. Although we have only been tracking visits for six months, we have noticed significant increases in several categories. Monthly visits to the main website, for example, increased from 996 in November 2010 to 1,338 at the end of May 2011. And single visitors increased from 650 in November to 1,060 in May. It is also interesting to note the number of visitors from countries outside North America over the six-month period (India: 316; Ethiopia: 141; Philippines: 113; Ireland: 97).

Patty Scheidl

As office manager, Patty is responsible for the centre's day-to-day operations and undertakes many additional duties as they arise. Regular duties include:

The Students and Contract Researchers

Bryce Donaldson, our co-op intern who will be with us until August, is working with Nora, Michael, and Lou on a variety of projects, some involving the wrap-up of the Social Economy project, some involving the ongoing arrangements for the Building Community exhibit, and some involving grant applications.

Monica Juarez Adeler has completed the second set of revisions of the first three chapters of her PhD dissertation and is working on the final chapters. During the spring term she taught the newly created Management of Co-operatives class to thirty-six students in the University of Winnipeg's Business and Economics Department; the class concluded in April. In early May, she was a guest presenter at an Urban and Inner City Studies class taught by Judith Harris at the University of Winnipeg. She presented "Enabling Policy Environments for Co-operative Development: A Comparative Experience" at the CASC conference in Fredericton, where she also became a new CASC board member. And she is running for a position on the Association of Cooperative Educators board; that nomination will be decided at the conference at the end of July. Monica also maintains her role as administrator for the Social Economy Project's Manitoba partner, the Institute of Urban Studies.

Rob Dobrohoczki is working on the propsal for his dissertation. His class in Coop Law concluded in April; he continues to work part time as a lawyer. He has two publications forthcoming — the chapter he assisted Brett with in the forthcoming book "Community Survival: Co-operative Solutions for Local Economies," sent to UBC Press in June, and "Credit Unions and the Construction of Locality: The Case of South Interlake Credit Union, Canada," an article submitted to the Journal of Co-operative Studies. Rob is president of the Good Food Junction Co-op at Station 20 West in Saskatoon.

Mitch Diamantopoulos is the head of the School of Journalism at the University of Regina. He has completed his PhD dissertation on the promise and potential of

worker co-operatives in Canada and will defend it in early July. The title of his dissertation is "Globalization, Social Innovation, and Worker Co-operatives: A Comparative Analysis of Co-operative Development in Quebec and Saskatchewan from 1980 to 2010."

Mike participated in both the ANSER and CASC conferences in Fredericton in June, presenting "The Rhythms of Education: The Role of Foresight and Wisdom in Co-operative Practice" at a joint session. Mike continues to sit on the board of the Saskatoon Community Clinic as well as the Community Clinic Foundation.

Patricia Elliott has completed the course work and comprehensive exams for her InterD PhD in the Co-op Concentration. Her committee recently accepted the proposal for her dissertation, which will focus on various kinds of community and co-operative media in Saskatchewan. Patricia is director of the Community Research Unit at the University of Regina and also teaches in the School of Journalism.

Maria Basualdo is in the second year of her PhD studies in the InterD Co-op Concentration. Her research topic is "Indigenous Women's Community Development: A Comparison of Canada and Latin America." She is currently working on contract with CIDA in Peru, where she is also pursuing field work for her dissertation.

Annette Johnson is currently taking the last course for her PhD in the InterD Coop Concentration and will soon be moving on to her comprehensive exams. Her dissertation is titled "Finding a Way Out: An Investigation into the Amalgamation of Worker Co-ops and Canadian Unions." Annette is the lead sociology instructor at the Regina SIAST campus and teaches an introductory course as well as Aboriginal awareness. She also teaches a course at the University of Regina titled Social Structure and Personality. Annette has been accepted into the European Summer School on the Social Economy, 18–22 July, in Bertinoro, Italy, an extension site for the University of Bologna. The school is sponsored by the European Research Institute on Cooperative and Social Enterprises, the EMES European Research Network, and the University of Bologna.

Tsegi Chuluunbaatar will finish her MA coursework this summer with a special topics reading class, INTD 898.3: Co-operatives and International Development, with Michael Gertler. She is working on her research proposal and ethics approval and in September will leave for Mongolia, where she will conduct her research — case studies on selected rural Mongolian co-ops. She plans to finish her thesis by next summer.
