Successful Letter of Intent

We've just heard that the Letter of Intent to SSHRC's Community-University Research Alliance program for a project that proposes to measure the impact of co-operatives in Canada has been successful. Our partners in this project are CCA, St. Mary's University, Mount Saint Vincent University, and the BC Institute of Co-operative Studies, with John Anderson at CCA and Sonia Novkovic at SMU the principal investigators. The success of the LOI means the partnership will receive \$20,000 to develop the full application, work on which will begin almost immediately.

▲ Social Economy Project Update

There is not a great deal new to report on this large undertaking. Projects are humming along as expected, with two more final reports having been submitted and a number of others in their final stages.

Due to the retirement of Tom Carter and the departure of Anita Friesen from the Winnipeg Inner-City Research Alliance, we have secured a new partner for the Manitoba region, the Institute for Urban Studies at the University of Winnipeg, directed by Jino Distasio. Centre PhD candidate Monica Juarez Adeler has replaced Anita. Monica has been involved with the project in Winnipeg for the past eighteen months, so the transition was a smooth one.

Plans are underway for another regional conference in February 2010; it is likely to take place in northern Ontario.

The exhibition of research results in preliminary planning with the Diefenbaker Canada Centre has been rescheduled for the late spring of 2010. After discussions with Diefenbaker Centre staff, it quickly became clear that the undertaking was far too complex for the brief timeline originally planned. Delaying the exhibition will allow time for many of the projects to be completed and thus give us a richer pool of results from which to draw. We have already established thematic areas and are currently working on an overall vision for the exhibition. Diefenbaker Centre staff have provided us with a variety of display units to consider and have prepared some preliminary mock-ups of display possibilities. It is proving to be a learning experience all round and we are enjoying the opportunity to work collaboratively with other units in the building.

Partners and Developments

This section highlights relevant issues and developments among centre sponsors.

SaskCentral (Karl Baumgardner reporting)

Financial (31 December 2008)

Net earnings were a loss of \$447 million, the worst financial results in the history of SaskCentral. The cause of the huge deficit is a provision of \$49.2 million for A.B.C. Paper (\$74 million for 07 and 08, representing 40 percent of holdings in A.B.C.P). Investee earnings were below budget by \$10.4 million. Assets increased \$45.3 million from plan to \$1.6 billion. A capital call was made to credit unions in December 2008, which raised \$12.4 million of membership capital.

Investees

SaskCentral provided Celero with an additional loan for \$5.3 million (Saskatchewan holds 31.4 percent of the shares). Credential Financial requested a \$7 million capital call.

Initiatives

The Centrals of Saskatchewan, Alberta, and Manitoba, as well as Concentra Financial, are developing a business strategy to create a Prairie Central. If credit unions approve, the merger is scheduled for 1 January 2011.

Delegates are lobbying MLA's for legislative changes to allow Saskatchewan credit unions to sell insurance within their branches and provide members with appropriate information.

Switching to "chip cards" is planned for 2010 and IFRS (International Financial Reporting Standards) is required for 2011.

The AGM is planned for 8 April in Regina, preceded by a conference 6–7 April.

The Co-operators (Karl Baumgardner reporting)

Financial (31 December 2008)

Pretax income was \$148.4 million (2007 was \$286.6 million). All operations were impacted by market turmoil. Costs of auto and storm claims were higher than anticipated. The Alberta courts rejection of a "soft-tissue" cap required a \$40 million provision. Capital ratios are well above OSFI (Office of the Superintendent of Financial Institutions) requirements. The board is proposing Price Waterhouse Coopers for external auditors to members at the AGM.

Growth

Annualized premiums were down for two-thirds of insurance companies but The Co-operators showed a gain.

Clients

Credit scoring will be used as a rating factor for homeowners' policies.

Services

Group critical insurance is now available. Information on health and dental plans will be available via online services.

Co-operatives

There are now forty-six members. The member loyalty distribution will be up to \$7.72 million.

Trust and Reputation

The sustainability program has been enhanced. The companies, staff, and agents contributed \$5 million to communities.

\$6.8 million in Community Economic Development funds have been allocated from 1995–2008.

We are in the midst of a library renovation that will result in more shelving for what has been a very crowded space. This will improve access to library materials and allow for more space for students to work in the library. We will also gain a publications room and secure storage for sensitive materials as well as space for a proper archive for historical Centre materials. Heather, too, will have a more suitable working space. The renovations will result in a lot of moving and shifting of books and journals, but will also provide an excellent opportunity to thoroughly review and refine the collection.

▲ The Websites

With Duy's assistance, we have set up a system that allows us to capture statistics relating to the usage of our LLL website, which has been extremely eye-opening and encouraging. It has been a pleasant surprise to discover that people from all over the world have been looking at information on our site and downloading reports. This has solidified our thinking that good website statistics are very important. Duy is in the process of installing a much more sophisticated website analytics tool to help us track users with even more precision. This will be useful in helping us post information in a manner that will attract the most viewers. We will use this tool with the new centre website as well. One of the goals is to send emails to authors of reports available on our website letting them know how many times their materials have been viewed and/or downloaded and, possibly, where those users are from.

The planned January launch of the centre's new website encountered some unavoidable delays; we are now aiming for sometime in the spring.

▲ Heather Begins to Twitter

In January, Heather attended the first Knowledge Mobilization Works Boot Camp in Ottawa and came away with some excellent contacts as well as some useful information for getting the word out about the work being done both at the centre and through the Social Economy project.

With the idea of knowledge mobilization on the brain, last week she started "Twittering." Twitter is a micro-blogging / networking tool and the fastest growing social networking system on the web. Within a week she had seventyeight people following her "tweets." As a test, she tweeted a link to a report on our LLL website (Financing the Social Economy) and within a few hours her web statistics indicated that eighteen people had followed her tweet to that report. She then tried tweeting a few other links with varying degrees of success. All in all, the experiment has proved encouraging and she will continue to tweet about our Social Economy project and co-operatives and monitor the success of Twitter as a knowledge mobilization tool. Anyone interested in learning more about the potential of Twitter for mobilizing information should contact Heather, and if you have information you would like her to tweet about, let her know. Her current followers are from the United States, the United Kingdom, and Canada.

The Students and Contract Researchers

Kim Brown has completed her project with Lou examining governance issues in the Advantage Credit Union system; it is with credit union officials for their comments. Kim continues to work part time on a CUISR internship writing a case study on La Ronge for the Social Economy project titled "Exploring the Social Economy in Saskatchewan." In December she left the centre for a full-time position in Regina as a case assessment officer for the Indian Residential Schools Adjudication Secretariat.

Dwayne Pattison is writing the report on the impact of retail co-op mergers and amalgamations on such things as membership participation, governance models, management, and community. He is currently doing the qualitative data analysis of the interviews he conducted at the end of 2008.

Dwayne was recently hired by CCA, CCCM, and the Co-operatives Secretariat to assist with a survey on co-operative research priorities. He is co-ordinating a meeting to be held in Ottawa at the end of March to discuss the survey in more detail and to establish a national research agenda on co-operatives. He and his Francophone counterpart are responsible for writing a report on the process and its outcomes, which will be made available some time in the summer of 2009.

Monica Juarez Adeler is working on her dissertation proposal. She is currently working in Winnipeg on a contract associated with the Social Economy project

titled "Building a Tax Policy Framework to Enable Co-operative Development." She has also taken over a co-ordinating role with our new Manitoba partner, the Institute of Urban Studies at the University of Winnipeg.

Rob Dobrohoczki is studying for his PhD comprehensives. He has one publication forthcoming, a chapter co-authored with Brett in the centre book *The Self-Help Solution: Co-operative Renewal in Canadian Communities.* This term he is teaching a course in co-operative law at the College of Law.

Zhao Jun continues to work on his PhD, though he intersperses these activities with other work. He recently reviewed the report "The Development of Farmers Organizations and the Small Farmers Adapting to Global Market Project," a project he has been involved with for the past couple of years in China.

Rochelle Smith continues to work on revisions to her PhD dissertation titled "The Relationship of Saskatchewan's Co-operative Community Clinics with the Government of Saskatchewan: Towards a New Understanding."

Mitch Diamantopoulos is working on the research and writing for his PhD dissertation on the promise and potential of worker co-operatives in Canada. He has one publication forthcoming, a chapter titled "Belonging, Comfort, and Home: Globalization, Social Exclusion, and Innovations in Co-operative Housing" for the centre book *The Self-Help Solution: Co-operative Renewal in Canadian Communities*.

Mike Chartier continues to work on a CUISR internship for a Social Economy project titled "Advancing the Co-operative Sector: Mapping Development Needs of Co-ops in Emerging, Underrepresented, and Struggling Sectors." He is working with the Saskatchewan Co-operative Association and Co-operative Ventures Worker Co-op. He also teaches grade eight at W.P. Bate Community School in Saskatoon and continues to work on his MA thesis on Watson Thomson, which he hopes to defend in the spring. As last year's Fredeen Scholarship winner, Mike gave the annual Fredeen Scholarship Seminar in December with a presentation titled "Adult Education and the Social Economy: Rethinking the Communitarian Pedagogy of Watson Thomson." Finally, Mike and his wife, Cynthia, had a baby on 1 March, a new little co-operator named Oscar Henri.

Kama Soles' Interdisciplinary Studies Master's thesis, "Empowerment through Cooperation: Disability Solidarity in the Social Economy," is investigating the potential that the co-operative model has for empowering people with disabilities, and will identify barriers to inclusion in the social economy and the formation of co-operatives. She has completed her coursework and is currently working on her independent research. Kama was awarded the 2009 Fredeen Scholarship and has also received a scholarship under Brett's "Cognition and Governance in the Social Economy" research project. Kama will be presenting "Leaders and Allies: The Role of Multistakeholder Co-operatives in Building an Inclusive Society" at the CASC conference in Ottawa this spring and plans to defend her thesis in the fall of 2009.

With Karlah Rudolph, she is also responsible for co-ordinating the Centre Seminar Series.

Tsegi Chuluunbaatar, who is at the course-work stage of her MA in the Co-op Concentration, has gone on medical leave, which we hope will be brief. Her thesis is tentatively titled "Increasing Opportunities for Women in Rural Mongolia through Co-operatives and Co-operative Models of Development."

Karlah Rudolph is working with Murray and Brett on Brett's SSHRC-funded project "Cognition and Governance in the Social Economy: Innovation in Multistakeholder Organizations." She has completed one year of course work for her InterD MA; her thesis is titled "Co-operative Response to Globalization of the Food Chain: Implications for the Emergence of a Sustainable Food System." Her work last summer compiling information on governance issues in social enterprises will be launched shortly on a website. She worked on a brief contract with Michael Gertler preparing a PowerPoint presentation on co-operative activity in Canada, which he presented at the University of La Laguna, Canary Islands, Spain, in December. Finally, Karlah works with Kama Soles co-ordinating the Centre Seminar Series.

Patricia Elliott, our newest InterD PhD student in the Co-op Concentration, is in her first year of course work. Her dissertation will study the social economy of community media, looking specifically at the impact of grassroots community radio across a broad range of social networks, points of tension, and ultimately, social change.
