Overview and Highlights

▲ Social Economy Project Update

We're pleased to announce that as a result of the July meeting and conference call with the adjudication committee for the project, we have been awarded our final two years of funding.

Our partners WIRA and CESD have several new projects underway; CUISR has no new projects but has extended funding to current projects where second stages in research seemed useful. To date, the Social Economy project has provided funding to fifty-three students across the node in the form of either scholarships or research stipends. We are extremely proud of the role this project is playing in supporting and mentoring these young researchers.

For a glimpse of the kind of exciting research this project is supporting, check out the blog (http://farmtoforkresearch.com/) of Colin Anderson and Dave Vasey, students at the University of Manitoba, who recently undertook a trek across western Canada interviewing farmers, farm leaders, and community activists engaged in alternative ways of moving food from farm to fork. This video/action research project will result in a documentary about grassroots solutions to the farm/food crisis.

Another exciting spin-off activity is a proposed exhibition of research results in cooperation with the Diefenbaker Canada Centre. To this end we are planning to collect audio and video clips plus lively photographs of researchers engaged in work with community partners that can be combined with the posters we have already created. It will be an excellent showcase of the work supported by the Social Economy project and show first-hand the community-university partnerships that form the basis for the research.

Final reports are beginning to be completed. Over the past few months Nora has prepared thirteen final reports for printing and posting to the website. She has designed a common cover so all the reports are clearly identifiable as Social Economy projects. The reports are available for circulation through the centre's library. We will monitor demand to determine if any of them should be printed for sale.

In dissemination activity, the centre partnered with the Community Health Cooperative Federation in organizing a conference on The Role of Co-operatives in Health Care, which was held 30 October in Saskatoon and attracted regional, national, and international participants (see more below).

The Role of Co-operatives in Health Care Conference

This conference addressed a major issue worldwide and was a significant undertaking for the centre this fall. Together with the Community Health Co-operative Federation, we hosted representatives of the International Health Co-operative Organization from Japan, India, Sri Lanka, Sweden, Spain, and across Canada for a one-day symposium on the role of co-ops in health care delivery.

While Saskatchewan experiences health co-operatives as comprehensive primary care clinics governed by their members, co-operatives internationally own hospitals, manufacture pharmaceuticals, and operate long-term care facilities. What do these co-operatives look like? How did they develop? In what kinds of public policy contexts do they operate, and what are the outcomes? How do our own coops compare? What opportunities exist and what kinds of public policies are required to realize the full potential of this model? Presentations from Canadians and international participants will attempt to answer some of these questions.

The involvement of Greg Marchildon from the Johnson-Shoyama Graduate School of Public Policy (Regina Campus) and also a co-applicant and researcher in the centre's Social Economy project, was a nice cross-pollination of two entities and, we anticipate, the first of many collaborative initiatives with this new school.

SaskCentral (Karl Baumgardner reporting)

Financial

Net earnings: \$16.1m (including \$6.3m for sale of c card business)

Assets: \$1.6b (\$133m above plan) R.O.E.: 12.69% (plan was 8.6%)

Dividend: \$15m paid to credit unions

Market Disruption (A.B.C. Paper)

The restructuring plan is proceeding after the Supreme Court ruled against appeals.

SaskCentral made a \$25.1m writedown in December 07 and this appears to be inadequate.

Technology

A three-year conversion program is proceeding. Many credit unions in the prairie region will convert to eroWorks.

IFRS (International Financial Reporting Standards)
SaskCentral is supporting credit unions in the transition from GAAP to IFRS, which comes into effect in 2011.

Prairie Central

The centrals of Alberta, Saskatchewan, and Manitoba are exploring the merits of creating a prairie central.

Fall Delegates Meeting

Delegates are meeting in Regina on 20 November. A meeting with MLAs is scheduled for 19 November.

The Co-operators

Financial

The Canadian P & C (property and casualty) remain stable. As of 30 June, pretax profit was \$104.2m (\$21.9m below 2007). The lower profit was related to storm losses, higher replacement costs, and lower value of investments.

Growth

The purchase of Addenda in April has raised assets under management from \$9.97b to \$39.3b. Client and staff retention is being maintained. The Quebec strategy is to establish a multidistribution model. Agencies now stand at 468.

Clients

Progress is being made in growing a multiclient base. New radio and TV ads began in the fall. The Community Guard for the voluntary/nonprofit sector has been well received in the Alberta pilot. The sustainability program has gained international recognition (Stockholm, Sweden).

Co-operatives

Current membership is forty-one with five new applications. Viterra has been recognized as a member replacing the former Saskatchewan Wheat Pool and Agricore United. Centrals of BC and Ontario have formed Central 1. Contributions were made to three co-ops for a total of \$26,700. Four staff have graduated from the CMEC Master's Program, St. Mary's University.

Trust and Reputation

Plans are being made for a parliamentary reception on 26 November. Talks with the Government of Saskatchewan have been held to seek permission for our agents to sell SGI products. The sustainability program is being enhanced. Through the directed donations program, \$221,875 was provided to 176 charities.

Concentra Financial (Mary Beckett reporting)

Operations

Financial Update (30 September): Despite the continuing market volatility, overall consolidated earnings results for Concentra are ahead of budget and prior year results on a year-to-date basis. There are positive variances to budget in the provision for credit (recovery) losses, noninterest income, and noninterest expenses, and financial results are tracking positively for the balance of the year.

Organizational Alignment: Concentra undertook further changes to its enterprisewide structure this year. Shifting from a vertical model of product development, implementation, support, and client delivery, it has moved to a horizontal model focusing each area on a core aspect of client servicing, product development, or organizational accountability. This horizontal model requires that integrated and collaborative approaches be used between divisions and departments, consolidating specialized expertise, enhancing communications, and ultimately increasing the enterprise-wide focus on clients.

Product Development

Tax-Free Savings Accounts (TFSA): Concentra has been working closely with Credit Union Central of Canada and the provincial centrals to assist in the development and rollout of this new product, which will be available to Canadian consumers in January 2009, in credit unions nationally. It is anticipated that the introduction of TFSAs will reduce federal revenues by \$5 million in 2008–09. Over the next twenty years, the annual tax savings will continue to grow to the point that experts estimate, relative to the size of today's economy, these tax savings will exceed \$3 billion annually.

Corporate Banking Expansion: In early 2008, this business line successfully expanded its presence in the British Columbia market with support from commercial and credit union clients in that market.

Strategic Planning

Through ongoing customer dialogue, consultations and formal studies, and client satisfaction surveys, Concentra continues to focus on establishing a consolidated viewpoint of current and future needs from our client partners. In August, the board of directors considered the environmental information and analysis and affirmed the long-term strategic intents of Position for Market Relevance and Expansion & Development as the focal points for all strategies employed at Concentra Financial.

Amalgamations and consolidations continue within the co-operative system as evidenced by continuing mergers at the credit union level (such as the megamerger in Alberta of Servus Credit Union) and the consolidation and realignment of provincial centrals (Central 1, the Atlantic Centrals, and the Prairie Initiative).

Market Conditions

Liquidity continues to be a key factor across Canada and throughout the global market. In the face of this, Concentra Financial focuses on prudently managing its financial resources. To accomplish this, key individuals from divisions across the enterprise are holding special joint meetings to ensure a co-ordinated approach to liquidity, profitability, and capital. This careful monitoring of the market conditions will continue until there is normalization of the market.

Dwayne Pattison, a former MA student at the centre, has been hired on a contract to study the impact of retail co-op mergers and amalgamations on such things as membership participation, governance models, management, and community. He has just returned from three weeks of interviews, during which he visited multibranch co-ops in Alberta, Manitoba, and southern Saskatchewan and met with members, board members, and management. His research is now in the analysis and transcription stage.

Dwayne is also finishing up the final report for a CUISR internship on the Big River Arts Marketing Co-op for the Social Economy project. And he was a presenter at the FCL Leadership Program 27 October in Saskatoon.

Rochelle Smith continues to work on revisions to her PhD dissertation titled "The Relationship of Saskatchewan's Co-operative Community Clinics with the Government of Saskatchewan: Towards a New Understanding."

Mitch Diamantopoulos is working on the research and writing for his PhD dissertation on the promise and potential of worker co-operatives in Canada. He has one publication forthcoming, a chapter titled "Belonging, Comfort, and Home: Globalization, Social Exclusion, and Innovations in Co-operative Housing" for the centre book The Self-Help Solution: Co-operative Renewal in Canadian Communities.

Mike Chartier continues to work on a CUISR internship for a Social Economy project titled "Advancing the Co-operative Sector: Mapping Development Needs of Co-ops in Emerging, Underrepresented, and Struggling Sectors." He is working with the Saskatchewan Co-operative Association and Co-operative Ventures Worker Co-op. He also teaches grade eight at W.P. Bate Community School in Saskatoon and continues to work on his MA thesis on the communitarian pedagogy of Watson Thomson, which he hopes to finish before Christmas.

Kama Soles' Interdisciplinary Studies Master's thesis, "Empowerment through Cooperation: Disability Solidarity in the Social Economy," is investigating the potential that the co-operative model has for empowering people with disabilities, and will identify barriers to inclusion in the social economy and the formation of co-operatives. She is currently taking her last special topic 898 course titled Disability Studies — Contexts and Constructions: Forming Disability Communities, and hopes to defend her thesis in the spring of 2009.

Tsegi Chuluunbaatar is engaged in course work for her MA in the Co-op Concentration. Her research will be supervised by Lou and Michael. Her thesis is tentatively titled "Increasing Opportunities for Women in Rural Mongolia Through Co-operatives and Co-operative Models of Development."

Karlah Rudolph, our most recent Social Economy scholarship winner, is in the CSALE Concentration (Centre for Studies in Agriculture, Law, and the Environment) and is working with Murray and Brett on Brett's SSHRC-funded project "Cognition and Governance in the Social Economy: Innovation in Multistakeholder Organizations." This past summer, she worked on an online toolbox for the governance node of the Social Economy project; the website will be launched at the end of October and features numerous training tools and resources for individuals interested in learning about effective governance in the social economy.

The title of Karlah's thesis is "Cooperative Response to Globalization of the Food Chain: Implications for the Emergence of a Sustainable Food System." It will examine how the governance of multistakeholder organizations involved in the sustainable food movement allows them to innovate and alter the current food system.

Patricia Elliott, our newest InterD PhD student in the Co-op Concentration, has begun course work this fall. Her dissertation will study the social economy of community media, looking specifically at the impact of grassroots community radio across a broad range of social networks, points of tension, and ultimately, social change.
