## Saskatoon Co-operative Association Consulting Contract

The final report for this project is complete and the final draft will be forwarded to the Saskatoon Co-op shortly. This project includes three major sections: a literature review and analysis of motivations for member engagement in large co-operatives, a framework for thinking about the process of decision making on boards and the characteristics that help lead to success, and a review of governance during amalgamations in the CRS system. The report created a framework for member engagement and effective decision making that enshrines the uniqueness of the co-op identity. Centre researchers have conducted and analyzed interviews with the board, examined comparable co-operatives, and developed case studies of a variety of co-operatives that have recently undergone amalgamations. Significant analysis of member level data was undertaken to ground research and recommendations in the member profile of the Saskatoon Co-op. Opportunities to publish or present on broad themes from this report will be ongoing.

#### CCUA Consulting Contracts

Canadian Credit Union Legislation: A Cross-Jurisdictional Scan

This past summer, third-year law student Bryden Wudrich undertook a comprehensive review of the credit union legislation and regulations in each province and, where appropriate, the federal Bank Act, then compiled a final report outlining the areas of similarity and difference. We delivered the report to CCUA at the end of August and provided an amendment to the contract to further investigate the required capital ratios, liquidity ratios, leverage ratios and deposit premiums for credit unions in each Canadian province. This research was completed and provided to CCUA at the beginning of November.

Stitching Together the Second Tier: Lessons from Federated Co-operatives Limited Jen Budney, a post-doctoral fellow with the Centre for the Study of Co-operatives, worked with Brett and Murray on an in-depth case study of FCL's success in ensuring member buyin and effectively using the second-tier model to achieve both governance and economic objectives. The research highlighted important issues for the credit union system to consider in implementing second-tier activities. We delivered the report to CCUA at the end of August.

#### Vancity Consulting Contract

Marc-André worked with Vancity on a project entitled Chair Selection, Tenure, Evaluation and Remuneration: A Co-operative Perspective. In this study, Marc-André used document analysis, interviews, and a literature review to identify the governance processes that contribute most to deepening and extending the co-operative nature of an organization, particularly with respect to board chair succession. A presentation and a report including analysis and recommendations were delivered to the board in October 2018.

## Graduate Certificate in the Social Economy and Co-operatives

Due to class scheduling issues, admission to the Certificate program was shifted from fall to spring. The core course — Co-operatives in the New Economy: Institutions, Policy, and Sustainability — was offered in a condensed format in May 2018. There was very little uptake in the certificate for a start in May. As a result, the online course — Co-operative Governance and Leadership in Action — that was to be offered from September 2018 to May 2019 has not been offered. Conversations are ongoing as to the next logical step for the certificate.

#### Online Course in Co-operative Governance

A major accomplishment a year ago was the launch of Governance in Co-operatives, a massive, open, online course (MOOC) aimed at unlimited participation and open access via the web using the Canvas Learning Management system. Paul Thompson will instruct the course again in January 2019 in a collaboration between the Centre and Co-operatives First. The governance model presented in the course focuses on the three key elements of successful governance: cognition, strategic interdependencies, and legitimacy. Four hundred eighty students took part in the first offering of the course beginning on October 16, 2017, with 50 earning a badge and 32 a certificate of completion. The course has also been running as a self-directed course since last winter. To date, 447 have enrolled, and 30 completed the requirements for the badge. It is free to anyone interested in deepening their understanding of co-operative governance. The modules have also been extracted for use independent of the Canvas platform.

#### History of the Centre for the Study of Co-operatives

As part of a submission to an upcoming Canadian Association for the Study of Cooperatives book on Higher Education and Co-operatives, the Centre for the Study of Cooperatives contracted with historian Merle Massie to write a history of the Centre. Through document reviews and interviews, the historical analysis explores what factors led to the establishment of the Centre, what has enabled its longevity, how the Centre has maintained ties and values alignment with the sector; the Centre's major achievements and the impact it has had on the sector and the academy, the Centre's role in the future and possible challenges moving forward, and lessons for closer collaboration between the sector and post-secondary institutions. Merle delivered the final manuscript in two pieces – the first a shorter piece on interdisciplinarity in the role of the Centre and the second a longer, historical look at the main themes in the evolution and success of the Centre. Final editing is occurring on these pieces; the shorter piece will be submitted as a chapter to CASC and the longer piece will be made into a Centre booklet.

#### Contemplating Co-ops — The Blog Update

A major focus in the next six months will be to revive the Contemplating Co-ops blog. The blog had been a significant driver of the Centre's online presence. Between June and November, there were no postings due to a variety of resourcing changes at the Centre.

#### Students

As a way to provide deeper engagement between faculty, graduate students, visiting scholars, and staff interested in and studying co-operatives, the Centre has organized and hosted ten student discussion seminars over the last year where students and faculty presented research on which they were currently working. Over the summer period, these seminars were halted, but are beginning again in the new academic year. As in previous years, attendees at the seminars will have opportunities for discussion, questions, and to provide suggestions to the presenters.

#### Co-op Week 2018 Activities

Darcy Overland, Esther Awotwe (one of our graduate students), Paul Thompson, and Murray Fulton attended the flag raising, the luncheon, and the co-op merit awards in Regina. Brett Fairbairn received the Co-operative Contribution Award and was there in person to accept it. Paul Thompson worked with the Saskatchewan Co-op Association to host a film screening of A Silent Transformation at the Broadway Theatre.

### Thematic Breakdown of Selected Centre Activity

The Centre for the Study of Co-operatives has at the core of its mission the creation of new knowledge about co-operatives. New knowledge is created in the minds of people: faculty, students, co-operative leaders, the public sector, and others who experience our events, activities, and initiatives in-person and through various media. The Centre's discovery mission is currently concentrated in the areas of co-operative governance, cooperative development, rural and agricultural communities, and Indigenous co-operation. The following sections provide more depth on these four areas.

# Governance — including co-operative theory, demutualization, leadership, management, community and social engagement (member or stakeholder voice), and policy

Governance is a critical determinant of the success or failure of organizations. Informed by the study of co-operatives and their distinctive issues, the Centre is producing a new synthesis of knowledge and theory about governance. This involves three elements: developing governance and organizational theory and publishing it in international forums to influence scholars and students of governance, applying theory to co-operatives and providing leaders with new insights into governance, and conducting case studies of co-operative governance.

The Centre's emerging approach views governance as the allocation of power within organizations and among stakeholders — governance is a basic question of the purpose of an organization and how it is conceptualized. Allocation of power through governance enables organizations to address three fundamental categories of problems: strategic interdependencies among stakeholders (co-operation and co-ordination among members, directors, managers, etc.), establishing a shared way of thinking to deal with an uncertain future, and maintaining legitimacy.

# Co-operative Development — including community and social engagement, measurement of impact, ethics, history, innovation, sustainability

The development of new co-operatives is a complex and sometimes mysterious process; a process that in the long run is important for the renewal of the co-operative sector. The teachings and history of the co-operative movement indicate that co-ops are formed by voluntary associations of people, usually at a local level, who want to address a need by forming an enterprise. At the same time, history shows that co-ops do not emerge everywhere they could, but in patterns and clusters — often connected with a citizens' or social movement, sponsorship by pre-existing co-operatives, or an action by the state. Some thrive more than others. The Centre discovers new knowledge about co-op development factors work together to produce successful co-op development. The Centre's approach involves a strong focus on understanding community needs, capacity, and leadership, and on identifying the specific kinds of interventions that can promote self-help. We look for the best insights from around the world and for ways these can be adapted and applied in Canada and elsewhere.

The development and empowerment of Indigenous communities in Canada and elsewhere is one of the great societal challenges of our time. The Centre aims to contribute by investigating the synergies or tensions between co-operative forms of enterprise and First Nations, Métis, and Inuit social-economic realities and models of governance. Centre faculty and students advance knowledge in these areas through empirical studies of the breadth and diversity of enterprises in Aboriginal communities; by engagement partnerships with First Nations, Métis, and Inuit communities and organizations to produce mutually beneficial knowledge; and by learning from Indigenous worldviews to identify ways Western organizational models can be broadened.
